The Election procedure will be as per Rule No.VI (22) of Memorandum and Articles of Association.

The Nomination Forms duly recommended and seconded by the Unit's Eligible voters, shall reach Unit's Office prior to 30 days of Election date i.e. on or before 7<sup>th</sup> January, 2021.



All Nomination Forms shall be sent in a sealed envelope mentioning thereon "Nomination Form" and addressed to the Unit's Secretary.

A decision taken by Scrutiny Committee with regard to the validity of the Nomination Form will be final and binding. The candidate whose nomination has been accepted, can withdraw his nomination with due intimation in writing to the Unit's Secretary before election procedure starts.

Election will be by secret ballot. If there are equal votes for any of the aforementioned post, the decision for that post will be taken by Election Officer.

Kindly note that all the aforesaid points are in the nature of directives. Memorandum and Articles of Association, Rules and Regulations thereunder as amended shall be referred to for election procedure and the same will be binding in all respects.

Considering present pandemic situation, the election shall be carried out as per then government guidelines.
